






Transcription files are saved in Rich Text Format (RTF), and can be opened in Word, simplifying post-recording review and enhancing integration into existing court systems.



#### **Predefined Phrases**

enables the court to set up commonly used phrases or names that may be challenging to spell or have specific formatting requirements, such as legal terms, court names, or individuals' names. Once a match is identified in the transcription process, the speech-to-text engine automatically inserts the predefined phrase directly into the text. This ensures consistency and accuracy in the transcription of frequently used terminology, minimizing errors and reducing the need for manual corrections.



#### **Note Bookmarks**

allows individual users to insert timestamped notes directly into the speech-to-text transcript, either during the session or afterward. This is especially helpful for making personal notes or correcting transcription errors that may arise from real-time processing. Users such as judges, attorneys, or court staff can connect to the in-room recorder from their own PCs, but each user's notes remain independent. This gives users the flexibility to take their own notes without affecting the generated transcript or interfering with others.



#### **Large Format Captioning**
