In addition to advanced features that expand access to justice—such as "Multilingual Access" and built-in SIP, VOIP, and WebRTC support—LVC records each participant on their own audio and video channels using Liberty Court Recorder, ensuring a comprehensive and organized capture of every hearing.


All-in-One Platform

Streamlines pre- and post-proceeding workflows by integrating video conferencing directly into Liberty Court Recorder (LCR). Unlike cloud-based tools, LVC allows in-room participants and remote parties to be recorded on independent audio and video channels, all saved to a single, locally stored file. This eliminates the need to download/merge recordings from external sources.




Court-Centric Control

Gives court staff full, discrete control over virtual hearings in a dedicated management window. While remote participants interact in a familiar window similar to Zoom or Teams, managers can control all aspects of a conference, including muting, placing participants on hold, or terminating connections. They can also move individuals from general lobbies across an entire courthouse to specific courtroom galleries, mimicking the intake process of real world in-person proceedings. This structure ensures organized and secure workflows and eliminates the complex coordination of hosting virtual meetings.



Multilingual Access and Simultaneous Interpretation

Simplifies pre-hearing preparation by generating participant links with all prompts in the foreign speaker's native language. They arrive better prepared and appear in the virtual lobby as a foreign speaker. This allows court staff to easily identify and manage foreign participants before a proceeding begins. During the session, up to three simultaneous interpreters can connect in different languages, providing real-time interpretation. Participants then have the option to use a built-in slider to seamlessly switch between the interpreted audio and the original courtroom audio, enhancing accessibility without disrupting the flow of the hearing.



User Roles and Color I.D.

Enhances hearing management by clearly identifying parties involved in a case through color-coded highlights that distinguish them based on their roles (e.g., Police Officer, Attorney, Witness, etc.). This feature improves organizational efficiency by providing court staff with a clear, immediate visual reference.
